- I have not been, nor any member(s) of my household, diagnosed with the COVID-19 virus within the last 30 days.

- I am fully and personally responsible for my own safety and actions while and during my participation and I recognize that I may be in any case at risk of contracting COVID-19.
- I hereby categorically declare that I have chosen to visit and avail services of the Gym therein on my own free will and upon understanding all risks & consequences including Covid 19 infection , that may occur from my presence and participation therein.
